- a) Entry to examination venue will be permitted only against a valid Admit Card, Original proof of identity card issued by any government agency such as Aadhar Card/ Voter ID/Driving Licence/PAN Card / Passport etc.
- b) Candidate who fails to appear on the designated date shall not be provided a second opportunity.
- c) No Travel/Accommodation allowance is admissible to the candidates appearing in the driving test. Candidates are advised to make their own arrangements for boarding and lodging etc.
- d) The MCC will not be responsible to pay for any damages in case of injury/death to any of candidate during conduct of various tests and thereafter.
- e) All the candidates are advised to follow the Covid guidelines issued by the Government of India/Chd Admn from time to time.
- f) The venue of Driving test for the post of Driver is mentioned above.
- g) All disputes shall be subject to the jurisdiction of UT, Chandigarh.
- h) In case the Driving test not possible due to weather or any other unforeseen circumstances, the date for the same would be 10.09.2022 (reserved date)
- i) No second opportunity will be given who fails in the driving test.
- j) Impersonation or fraud in any case would result not only debarring the candidate but criminal proceedings would be initiated against the candidate.
